**President's Message**

**The SPA At 80**

The first file in my "President's Notebook" is the SPA Charter. When I opened it up the other day I paused a moment to read it again. Its Second article states that the purpose of the organization will be: "... to promote the study of the archaeology of the American Indian, especially as represented in the State of Pennsylvania, to encourage careful scientific excavation in the field and to discourage careless and misdirected digging, to promote the conservation and preservation of important archaeology sites, to oppose the manufacture and sale of fraudulent antiquities, to encourage the establishment of local archaeological museums and organizations, to promote the spread of archaeological knowledge by means of meetings and publications, and to serve as a bond between the individual archaeologists and collectors in the state."

Here we are eighty years later. The words above have been changed slightly and abbreviated on our promotional brochures, but our mission has remained the same, and I think that our founders, including the likes of J.Alden Mason, G.B. Fenstermaker, and Francis Dorrance, would be very proud of the accomplishments we have achieved. Over the years, 29 chapters formed across the State, with 14 currently active. Our membership includes more than 500 amateurs, avocationalists, professionals and institutions not only in Pennsylvania, but also across the nation and beyond. We've produced upward of 165 issues of PA Archaeologist, conducted countless surveys and excavations, and registered hundreds of sites. Our efforts have aided in saving many sites from destruction, and the knowledge from many more to be saved as a result of salvage efforts. All of this has resulted from many trials and tribulations, but mostly from our members' love of archaeology and its ability to uncover the secrets of the past.

We are happy to have the PHMC host our 80<sup>th</sup> Annual Meeting, and the State Museum will be a great venue to celebrate 80 years of our saving the past for the future. Thank you all for your contributions to archaeology in Pennsylvania, and we hope to see you in Harrisburg April 3 – 5!

## **A report on the 2009 Pennsylvania Farm Show Exhibit Submitted by Kurt W. Carr**

Despite the fact that the 2009 Farm Show exhibit was recycled from last year, I think the exhibit was very well received by the public. There is no question in my mind that this presentation makes a difference in Pennsylvania archaeology. I continued to see excitement in the eyes of children and adults as they sat in the dugout, amazement as Bob Winters quickly formed a variety of stone tools and wonder as they stood gazing at the petroglyph banner. Over nine thousand brochures on Pennsylvania heritage were distributed, over 1400 coupons for the Curiosity Corner and the planetarium were handed out and we spoke to thousands of visitors.

Pennsylvania has an outstanding wealth of archaeological resources that I believe can enhance the lives of everyone. This exhibit and the information that was disseminated was one step in communicating this heritage to the people of Pennsylvania. As you all know, the archaeology of Pennsylvania is being destroyed at an ever-increasing rate. We need help in slowing this destruction. I feel the Farm Show exhibit represents a significant vehicle for the dissemination of information and for increasing the public's awareness of the threats to their archaeological resources.

In addition, I think this presentation is a great way to promote the goals of the Society for Pennsylvania Archaeology, Inc. This event represents the most intensive interaction with the public that we have all year. Using our sampling scheme of counting all visitors who came into the exhibit for two, one-hour periods each day, we touched between 50,000 and 60,000 visitors. This confirms the estimate developed by Brian Fritz last year. This is over 10% of all of the people who attended the Farm Show. This high volume of attendance is a testimony to the quality of the exhibit, the initiative of our volunteers in engaging the public and the public's interest in archaeology.

We are very interested in everyone's comments so please send me your thoughts. I would think that one of our goals for next year would be to increase the efficiency of getting our message or messages to the public. Obviously, we also need to address the issue of funding for next year. A meeting celebrating our success, and to prepare for Farm Show 2010, will be held in February.

### **A conference on transportation, Heritage and the Environment**

The Statewide Conference on Heritage will be held **May 19th-22nd**, 2009 at the Commonwealth Keystone Building in Harrisburg, PA. The joint conference will feature workshops, sessions and speakers from the historic preservation, archaeological, heritage tourism, transportation, legislative, and planning communities, including a number of nationally known speakers and subjects of state, regional and national importance. ## **SOS SAVE THE PHMC GRANT PROGRAM**

February 13, 2009

Dear Colleagues:

As many of you know, Governor Rendell deleted the Museum Assistance line item in his proposed budget for FY2009-2010. He also proposed never funding it again. It is up to us to work with the Pennsylvania General Assembly to reinstate the Pennsylvania History and Museum Grant Program that is administered by the Pennsylvania Historical and Museum Commission (PHMC). This line item is the only source for this essential grant program that has provided much-needed dollars for museums and historical organizations since 1985. We cannot allow it to disappear; our very existence depends on it.

While the Governor cut the Pennsylvania History and Museum Grant Program to \$0, he retained the grants for the nine "non-preferred" museums with a suggested reduction of ten percent. Art museums obtain their general operating support funding from the Pennsylvania Council on the Arts and should anticipate an eight-to-nine percent cut. This is grossly unfair to all the history museums, historical societies, science museums and technology centers, nature centers and arboreta, zoos, children's museums, maritime museums, transportation museums and others that have received and depended upon PHMC grant funding in the past. We demand fair funding for all grantees!

Our only hope is the Pennsylvania General Assembly. Our state senators and state representatives can return the funds to the Pennsylvania History and Museum Grant Program. However, it is up to you to tell your elected legislators **now** about how the elimination of museum funding will affect your institution and your community. Write letters to your state senator and state representative or even better visit their district offices; be impassioned in your appeal. Tell them what your community would lose if your organization was gone. Find contact information for your state legislators at [www.legis.state.pa.us](http://www.legis.state.pa.us).

On Monday, February 23rd, the State House Appropriations Committee will hold budget hearings on the PHMC's budget. It is crucial to contact your legislators by **Friday, February 20th**. We know that the most powerful incentive for legislative action is constituent response—from you, your board, your members and supporters. For your convenience, I am providing a sample letter with talking points following this letter and [on our website](#). Please forward this to the people that love your museum or historical organization. They will want the opportunity to support you. Also, send a copy of your letter or notification of your visit to [dfilipi@pamuseums.org](mailto:dfilipi@pamuseums.org). We need to keep track of our effort.

Thank you very much for your valuable help. Remember that Pennsylvania's economic crisis cannot be solved on the backs of its museums.

**Forks of the Delaware, Chapter 14**

**Editors Note: Each newsletter will feature an article on our chapters beginning with Chapter #1. The purpose is to become acquainted or reacquainted with our membership. Chapter submissions are always welcome.**

Chapter # 14, Forks of the Delaware Chapter, began its history on May 25<sup>th</sup>, 1962. The chapter founder's traveled to the Society for Pennsylvania Archaeology Annual Meeting being held in Wilkes Barre, PA. at Wilkes College. This meeting was hosted by Frances Dorrence Chapter # 11.

Our founding members were Elinor Fehr, H.Ben and Doris Freyermuth who were already state members for five years. Our founders were so enlightened by the meeting they decided to stay. An invitation was given to them by the Frances Dorrance Chapter to support a dig at the Schacht Site. A 10x10 was dug at this fortified Native American town assisted by Bill Strohmeier. This was the epiphany that caused these relic hunters to become students of archaeology. Their hard work and effort was realized later that year when Vincent Mrozoske, State Society Treasurer-Secretary, sent a notice September 21, 1962, to members in our local chapter. The first meeting for our new Chapter #14 would be held at the Northampton County Historical and Genealogical Society on September 27, 1962.

Before our group was officially organized as Chapter#14 we were asked to examine a field south of Kintnersville along the Delaware River. Bethlehem Steel Company discovered a skull with a front-end loader while loading sand and it was presumed to be historic. Eventually, sixteen burials were removed from the former Sam Overpeck Farm and many significant artifacts were recovered from a ten square area that was excavated. The burials were repatriated in the proper respected manner.


On May 25<sup>th</sup>, 1963, at the SPA Annual Meeting at Beaver Falls a formal petition was presented to the SPA Board of Directors. A charter was issued by the state to Chapter # 14, Forks of the Delaware. Newly formed Chapter #14 hosted the Annual Meeting at Lafayette College in 1968, East Stroudsburg University in 1975, Moravian College in 1979, Recessa Falls Boy Scout Reservation 2001, and Allentown, PA, 2007.

Two well known sites excavated by Chapter# 14 were the Overpeck Site, 36Bu5, an archaic site; the other was the Sandts Eddy Site 367Nm12, a transitional site. The Chapter has participated in many other sites: prehistoric sites such as Portland Pa sites 36NM2 and 3, Martin's Creek PA site 36NM13, and the Miga Site, in New Jersey on the prehistoric sites: Vanderbilt Site, Rader Site, Beers Site, and the Snyder Farm Site. In recent years the chapter has had excavations at the Lopresti Site owned by founding member Virginia and the late Joe Lopresti. Chapter# 14 has had a large number of distinguished members past and present which includes Elmer Erb, Fred Assmus, F. Dayton & Harold Staats, James Wright, Herbert C. Kraft, Michael Stewart, Judd Kratzer and Phillip Perazio to name a few that have contributed much to Pennsylvania archaeology.

At the present time Chapter# 14 holds meetings on the first Thursday of every month in Palmer Township Public Library, Easton Pennsylvania. Lately we have noticed a lack of new members like so many other SPA chapters have witnessed. To confront this problem we have established a special Membership Committee. We are working hard to attract new members by having announcements in local papers. We have established a liaison with the local historical society. In July we established a special meeting for non-members to bring in any artifact for identification as a community service. In August we have a picnic for members along with primitive games that include friendly competitions for throwing the atlatl and dart, and a favorite, the tomahawk throw.

It has been a few years since our chapter has excavated a site due to new laws, budget cuts, and unwilling landowners. We recently located a Late Paleo to Early Woodland Site, in Schuylkill County, called the Wosochlo Site, 36Sc81. It is the only known paleo site in this county. This site was discovered surface hunting by Chapter# 14 President, James Wosochlo. Fortunately it is on a relative's farm and protected from development. Crowfield (Paleo) type artifacts are being found and hopefully

excavations will begin this summer. A second site discovery has been made at the same farm with both prehistoric and historic artifacts recovered. This site is being considered for a future excavation. We hope that these sites will attract new members and encourage students alike to Chapter# 14 and secure future interest in Pennsylvania Archaeology. Currently we are supporting the Northampton County Museum and the Lenape Indian Nation in establishing a archaeology display for the new county museum to be built in Easton, Pa. The museum plans to be open by December of 2009.

## **National Park Service's 2009 Archaeological Prospection Workshop**

The National Park Service's 2009 workshop on archaeological prospection techniques entitled Current Archaeological Prospection Advances for Non-Destructive Investigations in the 21st Century will be held May 18-22, 2009, at the National Park Service's National Center for Preservation Technology and Training, Natchitoches, Louisiana. Lodging will be at the Ramada Inn. The field exercises will take place at the Los Adaes State Historic Site (a Spanish presidio and capital of the Spanish province of Texas between 1719 and 1772). Co-sponsors for the workshop include the National Park Service, the U.S. Army Corps of Engineers, Los Adaes State Historic Site, Northwestern State University of Louisiana, and the Louisiana Division of Archaeology. This will be the nineteenth year of the workshop dedicated to the use of geophysical, aerial photography, and other remote sensing methods as they apply to the identification, evaluation, conservation, and protection of archaeological resources across this Nation.
